

# Privacy Policy

Effective as of: December 16, 2025

This Privacy Policy governs how personal information is collected, used, and disclosed in connection with your access to and use of any website or online service that links to this Privacy Policy, including without limitation asunagilfoyle.com (collectively, the “**Sites**”). ## 1. ***Information Collection.***
