Shinigami Eyes, LLC, a Delaware limited liability company, and its affiliates, as applicable (“***Shinigami***” or “***we***”) respect the privacy rights of our users and are strongly committed to protecting your privacy. This Privacy Policy applies to personal information collected through this web site (“***this Site***”) and other Shinigami web sites and products or services as expressly indicated by Shinigami, including by providing a link to this Privacy Policy or otherwise displaying this Privacy Policy.

Personal Information We Collect

Shinigami, or where relevant a designated service provider, collects personal information through this Site, such as during registration, when you request certain services or products, or submit information, which may include your name, phone number, email address, etc. If you do not provide certain personal information, not all functionality on this Site will be available.

Do not provide information about others unless you are authorized to do so and consent to have all information used, disclosed, and transferred in accordance with this Privacy Policy.
